

"Grand View Park opened in 1923 on a 35 acre parcel of land. Its rides included the Thriller and Skyscraper roller coasters, a carousel, whip, scooter, whirlpool, whirl-the-wind, airplane swings, frolic, flier and Venetian swings. The park also featured a dance hall, restaurant, kiddie playground, and a long boardwalk along a 918 feet of river bank. Canoeing was along 900 feet of the river. They had two cement swimming pools; one 150 x 300 and a 200 by 225." (Jeffrey Stanton - 9/2013)



In 1923-1935, Grand View Park could be reached by Singac NJ Trolley. People came by trolley or railroad lines in Paterson, Clifton, Nutley, Rutherford, Newark and Jersey City.

The cost from Clifton to Singac to Grand View was 10 cents. The trolley stopped 3 blocks from the park gate. Admission was one thin dime.



Roscoe De Baun wrote about Grand View Park in his 1957 book about Fairfield NJ.




Roscoe William DE BAUN 12/16/1887—2/25/1958 (70)







Trolley's brought people from Paterson, to Little Falls across the Beattie's Mill, into Singac and then to the foot of Grandview Road.



The busse: left the club house shortly after 10.0 clock and on the way to the place of pleasure the kiddles were treated with fruit-cake and candy.

Mrs. Frances Diglio. wife of the standard bearer of the association. headed a committee of ladies who with several male members looked after the inventies and saw to it that they had all the fun possible. Joe Diglio went along himself and did his share in making the outing the success it turn-

ad out to be. Bryan McMahon, manager of the park got up a set of games for the youngsters and saw to it that all engoyed the various amusement devices and side shows the park contains. Sandwiches, cake, ict cream, milk and fruit were served ad lib throughout the day and the juveniles agreed to a boy and girl when they reached home shortly before nine o'clock last night that they knew better than ever before what it was to enjoy a perfect day.

In the late 20's, the largest swimming pool of the era (100 by 200 feet) was built in Grandview Park, ft featured a large pavilion with lockers and lounge chairs for sunbathing. The white sandy beaches were terraced and people canoed on and swam in the Passaic River.

There were two pools. Around 1959-1962, we used the deserted larger pool (this one) for baseball. Usually just 7 kids. Only Joey Pitti hit a homer out of the cement pool.

We used the smaller pool, that hat 20 foot high walls, for softball. Too many homers. We had only one softball. So after a homer, we had to climb over a high wall to search in the overgrown woods for the ball. Hence, we mostly used the larger pool which had low walls.
