Earl R. **Pierce** Fatally Hurt This Morning

1950

Earl R. **Pierce**, 65, West Baraboo, was fatally injured this morning when a truck ran over him, according to a report of Sauk County Traffic Officer M. L. Joyce. Mr. Pierce passed away at St. Mary's-Ringling hospital soon after the accident.

He had been employed as a flagman by the Alexander Construction company, engaged in blacktopping Highway 12, south of Baraboo. The report of the traffic officer states that he was struck by a White truck of the same company as the truck as backing up the Sauk hill and the driver, Duane M. Keech, Medelia, Minn., apparently did not see Mr. **Pierce**.

The rear of the truck apparently passed over Mr. **Pierce** and he was brought to the hospital, suffering from severe shock, crushed elbow and ankle, possible fracture of the pelvis and internal injuries.

Surviving him are his wife and nine children, Kenneth and Lamoine of Chicago, Victor of Madison, Jack of Baraboo, Jerry who is in the navy, Helen of Chicago, Mrs. Grace Postel of Madison, Mrs. James Hillcoat of Baraboo, and Mrs. Dorothy Fox of California.

He also leaves three brothers and two sisters, including Mrs. Charles Smith, Edward (Ted), and William **Pierce** of Baraboo.

Truck Runs Over, Kills 66-Year-Old Baraboo Resident

BARABOO — A 66-year-old resident of West Baraboo died of injuries in a Baraboo hospital Saturday after being run over by a truck on Highway 12.

Earl R. **Pierce**, who was flagman for the Alexander Construction Co., was fatally injured when

one of the company's trucks backed over him, according to M. L. Joyce, Sauk county traffic officer who investigated the accident.

The accident happened on Sauk hill, about 6 miles south of Baraboo, where the construction company is blacktopping a section of Highway 12.

Driver of the truck was Duane M. Keech, Medelia, Minn.

Mr. **Pierce** died an hour after being brought to the hospital.

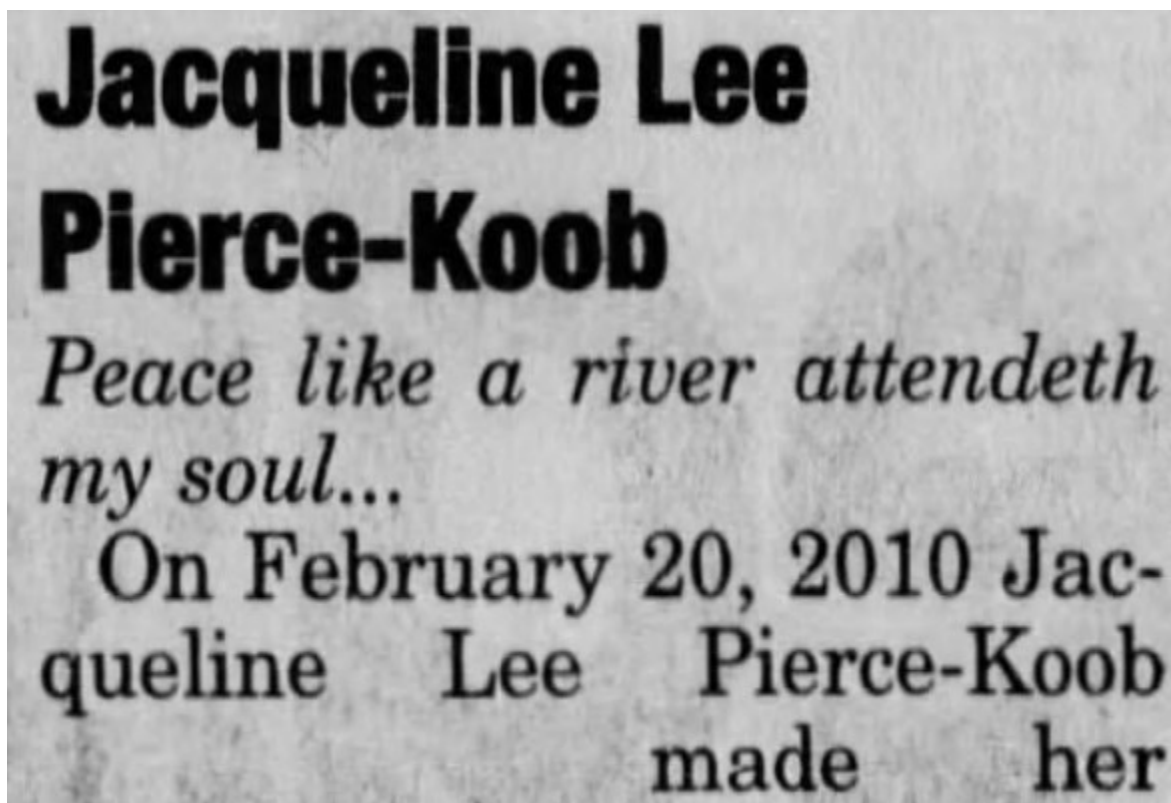

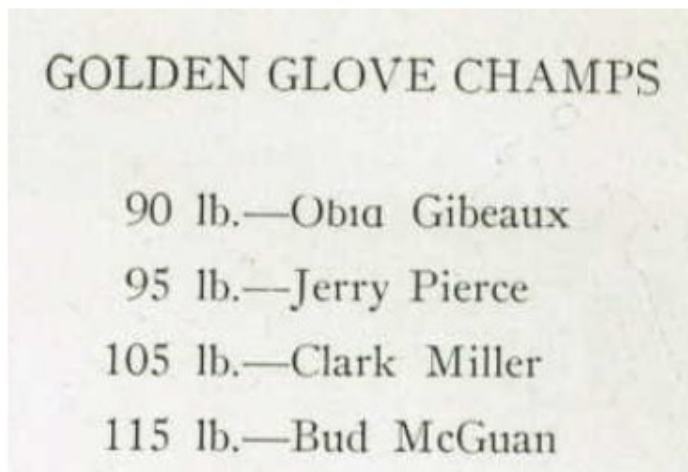
